

WORK/EMPLOYMENT

- 1. APPLICATION FORM [THIS WILL BE GIVEN AT THE SUBMISSION CENTRE]
- 2. PHOTOCOPY OF INTERNATIONAL PASSPORT DATA PAGE [TWO (2) COPIES]
- 3. THE INTERNATIONAL PASSPORT MUST REMAIN VALID FOR A MINIMUM OF SIX MONTHS FROM THE DATE OF TRAVEL.
- 4. OLD OR EXPIRED PASSPORT(S) SHOULD BE INCLUDED IF ANY
- 5. RESIDENT PERMIT FOR NON-NIGERIANS
- 6. 2 PASSPORT PHOTOGRAPHS WITH WHITE BACKGROUND
- 7. INSURANCE BY VOYA VISA
- 8. FLIGHT AND HOTEL RESERVATION AT LEAST 2 WEEKS FROM THE DATE OF SUBMISSION [AND MUST BE THE SAME DATE] NOT MORE THAN A MONTH FROM THE DATE OF SUBMISSION
- 9. HOTEL RESERVATION [IF NOT PROVIDED BY EMPLOYER]
- 10. ORIGINAL WORK CONTRACT [MUST INCLUDE EMPLOYER'S LIVE SIGNATURE AND STAMPED]
- 11. PHONE NUMBER OF EMPLOYER [STARTING WITH +905...] AND PASSPORT DATA PAGE OF CONTACT PERSON.
- 12. COMPANY REGISTRATION DOCUMENTS OF EMPLOYER
- 13. PHOTOCOPY OR SCANNED COPIES OF WORK DOCUMENTS ARE NOT ACCEPTED
- 14. INTRODUCTION LETTER FROM YOUR COMPANY OR SELF INTRODUCTION LETTER SIGNED IN INK
- -IN THE EVENT OF SPONSORSHIP, IT IS IMPERATIVE THAT THE SPONSORSHIP LETTER BE APPROPRIATELY NOTARIZED, AND THE SPONSOR'S BANK STATEMENT SHOULD BE PROVIDED IF SPONSORSHIP IS BEING LINDERTAKEN
- 15. 6-MONTH UP-TO-DATE PERSONAL BANK STATEMENT, ENSURING THAT THE STATEMENT INCLUDES A LIVE STAMP AND SIGNATURES. KINDLY NOTE THAT E-STAMPS WILL NOT BE ACCEPTED
- 16. BIRTH CERTIFICATE/DECLARATION OF AGE
- 17. PUBLICATION OF CHANGE OF NAME [IF MARRIED AND NAME APPEARING ON INTERNATIONAL PASSPORT DIFFERS FROM BIRTH CERTIFICATE]
- 18. MARRIAGE CERTIFICATE FOR COUPLES
- 19. APPLICANTS ARE REQUIRED TO SUBMIT A DULY ATTESTED POLICE CHARACTER CERTIFICATE (POLICE REPORT) AS PART OF THE DOCUMENTATION PROCESS.
- 20. WORK/OFFICE ID CARD
- 21. IF THE INVITING COMPANY IS BASED IN TURKEY, APPLICANTS ARE REQUIRED TO PROVIDE THE COMPANY'S PUBLICATION DETAILS AND CERTIFICATE OF INCORPORATION (CAC).

NOTE; THE CORPORATE SPONSORSHIP LETTER MUST BE SIGNED BY A DIRECTOR OF THE COMPANY, ACCOMPANIED BY A CAC CERTIFICATE AND LIST OF DIRECTORS, AS WELL AS A SIGNED VALID MEANS OF I.D OF THE DIRECTOR THAT SIGNED. ALL LETTERS MUST BE SIGNED (LIVE SIGNATURE)

SPONSORSHIP FROM A FOREIGN ENTITY OR INDIVIDUAL IS REQUIRED TO BE NOTARIZED IN THE SPONSOR'S COUNTRY OF RESIDENCE.
